Allen Family Foundation and NOC recognized for partnership

Enid was among 27 business and higher education partnerships throughout the state that were recently recognized as innovative collaborations that further the education of Oklahoma's workforce.

The businesses were honored last week at the University of Central Oklahoma.

Foundation have invested in Northern Oklahoma College, making meaningful contributions to students and programs while enhancing the quality of life in the Enid area communities in accordance to their mission of "supporting organizations that have a track record of success in education, rehabilitation or development to help individuals transform their lives and contribute to the larger community or society". For over twenty years, Northern Oklahoma College and the Allen Family have enjoyed a partnership centered around higher education and economic development.

Paul Allen, Entrepreneur, is a community and state leader who continues to invest resources for growing our businesses and developing our workforce. His family foundation has supported numerous NOC Enid student scholarships and grants through both the Enid Higher Education Council and the Enid Entrepreneurship Leadership Series. Additionally, the \$2 million donation to establish the Allen Family Oppor-

The Allen Family Charitable Foundation in tunity Scholarship through the Cherokee Strip Community Foundation assists Enid-area students achieve their dream of earning a college degree, especially those who are the first generation in their family to do so.

Allen and his late wife Joan have provided significant funding on the NOC Enid campus with projects such as the Failing Field Turf and the Paul Allen and the Allen Family Charitable Integris Indoor Baseball Facility. Through the Allen family's significant funding within the community, the David Allen Memorial Ballpark opened in 1999 and continues to be updated every year since. It is a successful public/ private partnership involving the non-profit ballpark association plus the City of Enid, Enid Public Schools and Northern Oklahoma College. The ballpark is host to the NJCAA Division II College World Series and the NOC Jets Baseball team is proud to call it their home.

Grants. State Regents' Chair Michael C. Turpen, State Regent Courtney Warmington, State Regent Steven W. Taylor, and Chancellor Allison D. Garrett participated in the ceremony, held April 27 at the University of Central Oklahoma.

Institutions involved in these partnerships provide \$500 for tuition waivers to employees of the partnering businesses; internships that enable current students to work at the partnering businesses; faculty externships with the partnering businesses; and/or enhancement of the partnerships with additional equipment, materials or supplies. The State Regents provide a \$500 match to the waivers.

NOC Rocket Team to participate in NASA RockOn! Program

As part of Northern Oklahoma College participation in the 14th Annual First Nations Launch High-Power Rocket Competition in Kenosha, Wisconsin, April 28-30, NOC was awarded the opportunity to participate in NASA's RockOn! Program.

This program is a hands-on workshop that teaches participants how to create a sounding rocket experiment and launch it as part of the orbital rocket launch. workshop.

Two of this year's team, Grant Biggers and Abbigayle Vargas, along with Dr. Frankie Wood-Black, Team Sponsor and the Division Chair of the Engineering, Physical Science and Process Technology Division will participate in this year's program to be held at the NASA Wallops

facility in Chincoteague, Virginia, June 16-22. This will culminate in a launch on June 22,

Dr. Wood-Black, indicated that a "sounding rocket" is a rocket that is designed to take measurements. As part of the workshop, the NOC Team will build a payload containing the experiment, and participate in the launch for a sub-

She said, "This is an exciting opportunity for our students as they will participate in a handson activity at a NASA site." She also indicated that this may allow NOC to participate in RockSat-C where students are to design, build and fly a sounding rocket experiment.

NOC students participated in the "Moon" pordesign and fabricate parts to lighten a standard rocket kit. Students chose the 4-inch diameter fiberglass Tomach Rocket Kit as their base rocket. For the competition, the nose cone, centering rings, and electronics bay were fabricated using 3-D printing technology. Additionally, the students fabricated other parts using aircraft plywood.

Dr. Frankie Wood-Black, the Team's Sponsor and Division Chair of the Engineering, Physical Science and Process Technology Division, said, "This competition provides students with real world engineering challenges. The students work for over six months to design, simulate, and build the rocket to meet the specified parameters. The students are required to prepare intermediate presentations detailing their de-

signs, challenges, and solutions, culminating in the High-Powered Rocket Launch at the competition."

While the final results of the competition are pending as students are required to submit a post launch assessment report. This year's rocket did complete its flight.

"While not everything went as planned the rocket was recovered and will be able to fly again," Wood-Black said.

Enid will host expanded NJCAA World Series through 2025

The city of Enid will continue to host the through the following week. NJCAA Division II Baseball World Series at least through 2025. The NJCAA on Monday announced the extended contract and an expanded format – moving from 10 teams to 12 teams - for the championship tournament for two-year colleges.

"We look forward to having this World Series in Enid once again,» said Brian Luckett, NJCAA senior vice president for external affairs and development. «The city of Enid continuously provides a quality championship experience for our student-athletes, coaches and fans, and we are excited for them to carry on that tradition.» David Allen Memorial Ballpark in downtown Enid has been the host of the World Series since 2009.

"The Enid fan base for baseball has set new standards for hospitality and we appreciate their efforts," said Bill Mayberry, ballpark director. "We are pleased to have the new NJCAA agreement reflecting that continued support of the positive experiences in Enid."

This year's 2023 NJCAA World Series will be May 27 through June 2 or June 3 at the Enid ballpark. The NJCAA, based in Charlotte, N.C., announced Monday a two-year extension of the agreement with Enid, the final step in a nationwide bidding and selection process to be the host site. College teams from across the nation compete throughout the spring season and then qualify to participate in the World Series by winning their regional and district tournaments.

Beginning in 2024, the tournament field will expand from 10 teams to feature 12 teams including 10 automatic qualifiers and two at-large selections, the NJCAA announced.

The 10-day tournament begins on Memorial Paul and Joan Allen. Day weekend each year, with games continuing

"Local youth baseball teams and community organizations are paired with each college team, ensuring local fans are cheering at every World Series game and each team has an Enid connection outside of the ballpark," Mayberry said.

World Series games typically attract large crowds of both area and visiting baseball fans, with the largest crowd topping 4,000 people when the Northern Oklahoma College-Enid Jets won the national championship in 2019.

"On behalf of the City of Enid, we are excited to host the teams in the NJCAA DII World Series for the next two years," said Scott Morris, assistant city manager and part of the local World Series planning committee. "We love meeting the players, watching them interact with the youth host teams, and of course watching the great American pastime. Downtown Enid and championship baseball are a perfect combination that we hope will add to that special nostalgia the fans appreciate."

David Allen Memorial Ballpark, built in 1999, is one nation's premiere amateur ballparks. It features an artificial turf infield and natural grass outfield with a large video board scoreboard. The classic traditional ballpark appearance includes a brick exterior and red brick outfield fence. The ballpark popular with teams and fans, hosting as many as 414 games per

The ballpark is a joint public-private partnership between the City of Enid, the Enid Public Schools and the non-profit David Allen Memorial Ballpark corporation working in cooperation with Northern Oklahoma College. It is named after the late son of Enid philanthropists
