# Introduction

The Northern Oklahoma College Fact Book is a collection of institutional data put together to provide information to those who make decisions, write grants, need institutional data for accreditation purposes, and to the general public interested in the institution. 

## About NOC

### History of NOC



Through the efforts of the Honorable James H. Wilkin, on March 1, 1901, the Oklahoma Territorial Legislature passed an act appropriating money to establish University Preparatory School at Tonkawa. Wilkin also obtained an endowment of land for the school. Consequently, Central Hall was constructed, a faculty employed, and other essentials of an educational institution provided. In September 1902, the doors of the new school swung open to prospective students. Two hundred and twenty-seven young men and women enrolled; thus opened the colorful history of one of Oklahoma's most important and picturesque educational institutions.

As the curriculum expanded and the enrollment increased, new equipment and other facilities became necessary. An act of Congress dated June 2, 1906, provided for the donation to the school of a section of land adjoining the city of Tonkawa. Proceeds from the sale of this land were to be used to provide additional buildings. A similar act of 1909 granted another tract of land for the same purpose. Harold Hall and Foster-Piper Fieldhouse were erected and paid for with the funds secured from the sale of these lands.

The college department was established in 1921, and the institution became a fully-accredited junior college. By an act of legislature in 1941, the name was changed to Northern Oklahoma Junior College. Further changes were made by the state legislature in 1965 with the passage of the Higher Education Code. This new statement of law changed the institution's official name to Northern Oklahoma College. Its three-man Board of Regents was expanded to five and given added authority and freedom in conducting institutional affairs.

In June 1999, Northern purchased the grounds and buildings of the Phillips University campus in Enid. Phillips University, a private institution established in 1907 by the Disciples of Christ, had closed its doors in August 1998. The purchase of the campus allowed Northern to expand its services to its Enid students and to provide for growth of its academic, student and community programs.

In 2001, Northern Oklahoma College celebrated the centennial anniversary of its founding, and, with the beginning of the fall 2002 semester, entered its second hundred years of providing quality education to students. The history of the institution is unique in the annals of higher education.

In August 2003, Northern joined in a partnership with Oklahoma State University to expand educational opportunities for college bound students in Oklahoma. The partnership allowed Northern to expand its services to its Stillwater students.





### **Tonkawa**

The Tonkawa campus, established in 1901, serves as the administrative center for Northern. All program oversight in academic, financial, student service, personnel, development, physical plant, and information technology is housed in Tonkawa. Over 1,500 students attend class on site, by ITV, or via online. Offering over 20 distinct degree paths with over 40 degree options and an array of courses, Northern distinguishes itself as a leading community college in Oklahoma.

### **Enid**

NOC began its presence in Enid in 1999, when it purchased Phillips University. The purchase was made possible by assistance from the Oklahoma State Regents for Higher Education (OSRHE) and the City of Enid. The site has a long history of offering college-level courses. The institution's original name was Oklahoma Christian University, which offered its first classes in 1907. The institution changed its name to Phillips University in 1912, due to the strong financial support from the T.W. Phillips family.

This site has grown in offering multiple two-year liberal arts degree programs to some 800 students each semester. The Enid site continues to expand its faculty, curriculum, and numerous clubs and activities.



### **Stillwater**

The Stillwater site, established in 2003, serves multiple missions to area students. Primarily a Gateway Program, the Stillwater site serves students who would otherwise not be admitted to Oklahoma State University. The site, however, also admits students seeking general education courses that transfer to other comprehensive colleges and universities. Northern Stillwater admits approximately 300 new students each fall and spring semester, serving some 1,700 students. March 2017, ground was broken for a New Classroom Building completed in August 2018.



## NASNTI Title III Grant

### NASNTI: Connecting Students to Promising Pathways, 2021 - 2026

This five-year project, funded by a \$2,248,867 Title III NASNTI grant from the U.S. Department of Education, started in 2021 with the aim of developing programs and services to support Native American and low-income students. Named "Connecting Students to Promising Pathways," the project includes three main initiatives. Significant progress toward the overall goals of the project was made during the second year, spanning from October 1, 2022, to September 30, 2023.

#### Initiative 1: Develop new STEM programs & course options

Eight (8) new courses were developed to expand STEM programs at NOC: Renewable Energy (4), Precision Agriculture (3), Data Analytics (1). Furthermore, specialized trainer systems for the Renewable Energy courses was purchased to support and educate students in relevant industry-related operating skills.

#### Initiative 2: Strengthen Student Services

The comprehensive needs assessment developed in year-one was refined in year-two to include questions specific to NOC's Native American students, proactively connect students with resources that support success. To strengthen career and transfer services, events were hosted to in the Career and Transfer Resource Center housed within the Pickens Learning Commons. Enhancements to NOC's online resources was achieved through the development of professional webpages in Health & Ag departments that outline the career and educational pathways related to each major.

#### Initiative 3: Build capacity to support remote learners with disabilities

Eighteen (18) Social Science & Business faculty earned certifications in principles of Universal Design for Learning (UDL) and five online courses from those departments were revised with UDL's principles in mind.





### Gender Count 2020-2021








Job Placement Rates Within 6 Months of Graduation



Hire/Rehire - Employer Response








**Job Placement Rates Within 6 Months of Graduation**

- The 2024 Sheep Field Day was held on Monday, July 15th. This event is hosted by the NOC Sheep Center

and the NOC Livestock Judging Team, under the direction of Bart Cardwell and Jennifer Bedwell, respectively, and is held annually the day prior to the Big 3 Field Days at Oklahoma State University. This year's event had a record number of entries with 95 teams and 45 individual participants totaling 347 FFA and 4-H members from across the state. - "After today I have a better understanding of what law school is in general, and also how accounting can be seen in everyday jobs regardless if that's the career you sign up for. Overall, it was exciting to learn about new careers and paths that I had no clue existed and to also get out on campus and attend a club. It was my first experience and was extremely educational and fun!"
- On 10/9, 16 students heard a talk by Alex Epstein entitled "Fossil Future: Climate Catastrophe or Climate Mastery," at a meeting hosted by the OSU Free Enterprise Society and Young America's Foundation. This meeting had the added excitement of encountering protestors who objected to the speaker's message. The controversy heightened the interest of students and caused them to listen more carefully to discern their own opinions on the issues of solutions to climate change.
- Tonkawa Kappa Beta Delta and Business Club had a joint meeting on September 28th. The students created a flyer for the NOC Beautification Committee to market for a cleaning up around campus event. They provided input into the NOC Business Division webpage and researching ways to better market the division for recruiting new students and providing relevant information to current students.
- 62 business students qualified for membership in Kappa Beta Delta honor society. These students must have a 3.0 GPA or higher, be in the top 20% of their class and have completed six business credits toward their major.
- The tutor for Digital & Financial Literacy on the Stillwater campus is a HUGE success, with a significant amount of improvement in students' grades on assignments.
- Todd Ging spoke to the Cimarron school and surrounding schools on November 9th at their Veteran's Day program. He talked about who is a veteran and addressed this year's theme from the Veteran's Administration of service.
- Jill Harmon and Cara Beth Johnson provided auditing services to the Miss NOC Pageant on October 17th.
- The Business Programs Advisory Board met on October 24th. The Board had great discussion regarding curriculum, program offerings, industry outlooks and skills gaps. ### **Nursing**

- It’s official! Northern Oklahoma College 2023 nursing graduates achieved 100% first time pass rate on the national registered nurse licensure exam. On April 1, 2023, the National Council of State Boards of Nursing launched the Next Generation NCLEX (NGN) Examination, an enhanced version of its predecessor, the NCLEX. NOC graduates performed ahead of state and national averages on the next generation NCLEX-RN achieving a 100% pass rate during the period of April 1-June 30, which is the first testing period of the NGN. In comparison, the state pass rate was 93.77%, and the national pass rate was 94.31% for the same time period.
- Beginning fall semester 2023, Nursing has begun offering Supplement courses to provide additional support to students in theory courses during semester 1 and beyond. These courses will be taught by the Success Specialist, and enrollments during this first semester are strong. A late-12 option will also be offered. A supplement for practicum is planned beginning in the spring semester. These courses are designed to improve student success in theory and practicum courses.
- The Nursing Division hosted 25 clinical facility and educational representatives for our annual Health Career and Education Fair on October 19 in Tonkawa.
- The fall 2024 White Coat Ceremony honoring the first semester students as they transition from practice lab to the clinical setting was held November 7 at 1:00pm in Montgomery Hall, Enid.
- Cohort agreement established with Saint Francis South Hospital in Tulsa to admit 8 students each semester who will complete all clinicals at Saint Francis – this will begin fall 24, and we will need to begin marketing for recruitment.
- Establishing a cohort agreement with Integris Bass to admit 8 students each semester who will complete all possible clinicals at Integris Bass (Enid) – will have specialty clinical experiences either through other Integris facilities or those we have contracts with for specialties.
- Working with Integris Ponca City on a new work-based track for those who are already working and want to advance their education.
- Nursing supplement courses were implemented to provide additional support for at-risk students. Nursing is also working on a curriculum change proposal that will be coming before the BOR in the spring

semester for approval to strengthen student preparedness for the rigorous nursing program to improve student success.

- Dr. Hicks worked with a group of Deans and Directors to develop the articulation agreement for LPN to ADN programs, and we are prepared to implement the final changes in our admission process immediately. Nursing has already been working to reduce barriers to admission for LPNs and implemented a new process eliminating the admission assessment for licensed LPNs effective fall 2023. LPNs now take a placement exam during the Transition to Registered Nursing course and receive individualized remediation and support to help them be successful in the associate degree program. We have already seen an increase in LPN applications during this academic year, and the trend is continuing for the fall 2024 application cycle.
- The nursing program admitted the first spring cohort on all campuses this semester and currently has 4 cohorts enrolled across the three campuses locations. 16 students started the nursing program this semester, and 15 students are currently enrolled (one student withdrew due to personal reasons). 46 students are continuing in the program with 17 students on track to graduate in the spring.
- Dr. Nikole Hicks attended an Elsevier Advisory Board Meeting in New York City over spring break.
- 23 nursing students and three instructors attended Nurses Day at the Oklahoma State Capitol.
- The spring White Coat Ceremony honoring first semester students who are entering clinical practice and Honor Society induction was held in Stillwater on March 12. Five students from each campus received their white coats and two were inducted into Alpha Delta Nu Honor Society.

Term	Definition
<b>ACT</b>	IPEDS definition: ACT, previously known as the American College Testing program, measures educational development and readiness to pursue college-level coursework in English, mathematics, natural science, and social studies. Student performance does not reflect innate ability and is influenced by a student's educational preparedness.
<b>Academic Program</b>	IPEDS definition: An instructional program leading toward an associate, bachelor, master, doctoral, or first-professional degree or resulting in credits that can be applied to one of these degrees.
<b>Academic Year (AY)</b>	The period from May of one calendar year to May of the following year during which students attend an educational institution. It includes a summer, fall, and spring term or semester.
<b>Accrediting Agencies</b>	IPEDS definition: Organizations (or bodies) that establish operating standards for educational or professional institutions and programs, determine the extent to which the standards are met, and publicly announce their findings.
<b>Alumni</b>	A graduate or former student of a college.
<b>Associate Degree</b>	An award that normally requires at least 2 but fewer than 4 years of full-time equivalent college work.
Associate in Arts	A two-year degree preparing students for transfer to a four-year institution with a foundational education in liberal arts.
Associate in Science	A two-year degree preparing students for transfer to a four-year institution with a foundation in science, engineering and mathematics.
Associate in Applied Science	A two-year degree designed for students who intend on entering the workforce immediately following graduation.
<b>Board of Regents</b>	The Northern Oklahoma College Board of Regents has a cooperative relationship with the State Regents for Higher Education. The State Regents act as a coordinating board for members of the state system in such areas as program approval and fund allocations. The Northern Oklahoma College Board is empowered with statutory authority for governance of its own institution.
<b>Catalog</b>	The Catalog offers information about the academic programs and support services of the College. Website: <a href="http://northok.publishpath.com/catalog2">http://northok.publishpath.com/catalog2</a>
<b>CIP Code</b>	Classification of Instructional Program Code organized by the National Center for Education Statistics. A six-digit code in the form xx.xxxx that identifies instructional program specialties within educational institutions.

<b>Cohort</b>	A specific group of students established for tracking purposes.
<b>Credit Hours</b>	IPEDS definition: A unit of measure representing the equivalent of an hour (50 minutes) of instruction per week over the entire term. It is applied toward the total number of credit hours needed for completing the requirements of a degree, diploma, certificate, or other formal award.
<b>Default Rates</b>	The rate at which debt holders default on the amount of money that they owe.
<b>Cohort Default Period</b>	The phrase “cohort default period” refers to the three-year period that begins on October 1 of the fiscal year when the borrower enters repayment and ends on September 30 of the second fiscal year following the fiscal year in which the borrower entered repayment. Students who enter repayment in 2009 and default in 2009, 2010, or 2011 are reported in 2012.
<b>Degree</b>	IPEDS definition: An award conferred by a college, university, or other postsecondary education institution as official recognition for the successful completion of a program of studies.
<b>Degree Award Date</b>	The date at which a student finishes the coursework necessary to obtain a degree and the educational institution awards the degree.
<b>Developmental Courses</b>	Courses offered to aid students in obtaining the educational information needed to proceed into a college level course.
<b>Distance Learning</b>	<p>The use of technology to offer course instruction to students not necessarily present with the instructor.</p> <p><b>Traditional:</b> A class is considered “traditional” when instruction relies solely upon face-to-face instruction with 800 minutes of seat time per credit hour issued.</p> <p><b>Web-enhanced:</b> A web-enhanced class is one in which a Learning Management System (e.g. Blackboard) is used for posting notes and/or homework assignments as a supplement to traditional class meetings.</p> <p><b>Hybrid:</b> A hybrid class represents a mixture of traditional and online elements with a minimum of 65% face-to-face instructional time and the use of a Learning Management System (e.g. Blackboard) as a supplement for either synchronous or asynchronous learning with the expectation of student interaction with other students and the teacher.</p> <p><b>Online:</b> An online class is one in which 75% or more of the instruction occurs through the use of a Learning Management System such as Blackboard.</p> <p><b>ITV:</b> Interactive television courses—delivery might be traditional, web-enhanced, or hybrid.</p>

On most matters, a consensus rather than a formal action may be sought.	
<b>Fall Cohort</b>	
IPEDS: The group of students entering in the fall term established for tracking purposes. For the Graduation Rates component, this includes all students who enter an institution as full-time, first-time degree or certificate-seeking undergraduate students during the fall term of a given year.	
<b>High School Diploma or Recognized Equivalent</b>	
IPEDS: A document certifying the successful completion of a prescribed secondary school program of studies, or the attainment of satisfactory scores on the GED or another state specified examination.	
<b>Financial Aid</b>	
IPEDS: Federal Work Study, grants, loans to students (government and/or private), assistantships, scholarships, fellowships, tuition waivers, tuition discounts, employer aid (tuition reimbursement) and other monies (other than from relatives/friends) provided to students to meet expenses. Foundation Grants	Financial support from any external agency which is handled through the Northern Oklahoma College Foundation.
Gender	The sex of the individual.
GPA	Grade point average of a student is a calculation based off of a student's credit hours taken and grades received for those credit hours.
Graduation Rate	IPEDS: The rate required for disclosure and/or reporting purposes under Student Right-to-Know Act. This rate is calculated as the total number of completers within 150% of normal time divided by the revised adjusted cohort.
Grants	Non-repayable funds or products (an award) disbursed to a grantee (recipient).
Headcount	The total number of individuals enrolled in the educational institution or program.
High School GPA	A student's weighted or unweighted GPA from his/her high school transcript.
High School Rank	A student's placement in high school compared to peers in the same grade based on GPA.
Higher Learning Commission	The Higher Learning Commission (HLC) is an independent corporation that was founded in 1895 as one of six regional institutional accreditors in the United States. HLC accredits degree-granting post-secondary educational institutions in the North Central region.



<b>Institution of Higher Education</b>	A term formerly used in IPEDS and HEGIS to define an institution that was accredited at the college level by an agency or association recognized by the Secretary, U.S. Department of Education. These schools offered at least a one-year program of study creditable toward a degree and they were eligible for participation in Title IV Federal financial aid programs.
<b>IPEDs</b>	The Integrated Postsecondary Education Data System. A system used by the U.S. Department's National Center for Educational Statistics (NCES) that annually gathers information from educational institutions of higher education and vocational institutions that participate in federal student financial aid programs.
<b>Major</b>	A field of study that a student chooses to receive a degree in.
<b>Race/Ethnicity</b>	IPEDS definition: Categories developed in 1997 by the Office of Management and Budget (OMB) that are used to describe groups to which individuals belong, identify with, or belong in the eyes of the community. The categories do not denote scientific definitions of anthropological origins. The designations are used to categorize U.S. citizens, resident aliens, and other eligible non-citizens.
American Indian or Alaska Native	IPEDS definition: A person having origins in any of the original peoples of North and South America (including Central America) who maintains cultural identification through tribal affiliation or community attachment.
Asian	IPEDS definition: A person having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian Subcontinent, including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam.
Black or African American	IPEDS definition: A person having origins in any of the black racial groups of Africa.
Hispanic/Latino	A person of Cuban, Mexican, Puerto Rican, South or Central American, or other Spanish culture or origin, regardless of race.
Native Hawaiian or Other Pacific Islander	A person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands.
White	A person having origins in any of the original peoples of Europe, the Middle East, or North Africa.
Race and Ethnicity Unknown	The category used to report students or employees whose race and ethnicity are not known.
Non-resident/Alien	A person who is not a citizen or national of the United States and who is in this country on a visa or temporary basis and does not have the right to remain indefinitely.
<b>Residence</b>	Location at which a student is living.

Term	Definition
<b>Retention</b>	IPEDS definition: A measure of the rate at which students persist in their educational program at an institution, expressed as a percentage. For four-year institutions, this is the percentage of first-time bachelor's (or equivalent) degree-seeking undergraduates from the previous fall who are again enrolled in the current fall. For all other institutions this is the percentage of first-time degree/certificate-seeking students from the previous fall who either re-enrolled or successfully completed their program by the current fall.
<b>SIS</b>	Student Information System - a data warehouse that contains all the data related to the institution.
<b>State Grants</b>	A financial award given by the state government to a grantee (recipient residing in the corresponding U.S. state).
<b>Strategic Plan</b>	A systematic process of envisioning a desired future and translating this vision into broadly defined goals or strategies and a sequence of steps to achieve them.
<b>Student</b>	
Concurrent	Student enrolled in high school and taking college coursework at the same time.
First-time Full-time student	Student enrolled in 15 or more credit hours of course work for the first time at any educational institution.
First-time Student	IPEDS: A student who has no prior postsecondary experience (except as noted below) attending any institution for the first time at the undergraduate level. This includes students enrolled in academic or occupational programs. It also includes students enrolled in the fall term who attended college for the first time in the prior summer term and students who entered with advanced standing (college credits earned before graduation from high school).
Full-time Student	Student enrolled in 12 or more credit hours a semester.
Part-time Student	Student enrolled in between 1-11 credit hours a semester.
<b>Student Handbook</b>	Handbook containing policies and procedures for students at Northern Oklahoma College. Website: <a href="http://northok.publishpath.com/student-handbook">http://northok.publishpath.com/student-handbook</a>
<b>Time to Degree</b>	Time a student takes to finish a degree. For a two-year institution 100% of time to degree would be two years. For 150% time to degree, time to degree would be three years.

Term	Definition
<b>Title IV Aid</b>	IPEDS: Title IV aid to students includes grant aid, work study aid, and loan aid. These include Federal Pell Grant, Federal Supplemental Educational Opportunity Grant (FSEOG), Academic Competitiveness Grant (ACG), National Science and Mathematics Access to Retain Talent Grant (National SMART Grant), Teacher Education Assistance for College and Higher Education (TEACH) Grant, Federal Work-Study, Federal Perkins Loan, Subsidized Direct or FFEL Stafford Loan, and Unsubsidized Direct or FFEL Stafford Loan.
<b>Title IV Institution</b>	IPEDS: An institution that has a written agreement with the Secretary of Education that allows the institution to participate in any of the Title IV federal student financial assistance programs (other than the State Student Incentive Grant [SSIG] and the National Early Intervention Scholarship and Partnership [NEISP] programs).
<b>Transcript</b>	An official record of student performance showing all schoolwork completed at a given school and the final mark or other evaluation received in each portion of the instruction. Transcripts often include an explanation of the marking scale used by the school.
<b>Transfer of Credit</b>	IPEDS: The policies and procedures used to determine the extent to which educational experiences or courses undertaken by a student while attending another institution may be counted for credit at the current institution.
<b>Transfer-out Rate</b>	Total number of students who are known to have transferred out of the reporting institution within 150% of normal time to completion divided by the adjusted cohort.
<b>Tuition</b>	The amount of money charged to students for instructional services. Tuition may be charged per term, per course, or per credit (NOC charges per credit hour).
In-state Tuition	The tuition charged by institutions to those students who meet the state's or institution's residency requirements.
Out-of-state Tuition	The tuition charged by institutions to those students who do not meet the institution's or state's residency requirements.
<b>Two-year Institution</b>	IPEDS: A postsecondary institution that offers programs of at least 2 but fewer than 4 years duration. Includes occupational and vocational schools with programs of at least 1800 hours and academic institutions with programs of fewer than 4 years. Does not include bachelor's degree-granting institutions where the baccalaureate program can be completed in 3 years.
<b>Unduplicated Headcount</b>	IPEDS: The sum of students enrolled for credit with each student counted only once during the reporting period, regardless of when the student enrolled.
