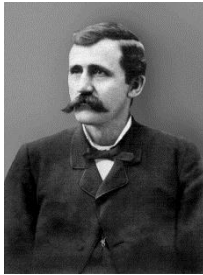

## About NOC

### History of NOC



The history of Northern Oklahoma College began in 1901 when the Honorable James Wilkin realized the need for a college in the Tonkawa, Oklahoma, area. Thus, the sixth Territorial Legislature passed an appropriation bill on March 1, 1901, for the establishment of the University Preparatory School at Tonkawa. The doors opened to 217 students and 7 faculty.

During the first two decades, the school served primarily as a "feeder" institution for the University of Oklahoma and paralleled the university curriculum of music, foreign languages, business, literature, and military science. In addition, the school served as a cultural center for the performing arts, a distinction that continues today with the 2006 dedication of the Kinzer Performing Arts Center.

Of utmost importance was the school's first accreditation by the North Central Association of Colleges and Universities in 1948. Then, with the passage of the Higher Education Code in 1965, the institution received its present name, Northern Oklahoma College, and the three-person Board of Regents was expanded to five members. During the last two decades, Northern has expanded its physical plant, broadened its curriculum, increased its student enrollment, and developed campuses in Enid and Stillwater.

Additionally, Northern is a leader among Oklahoma colleges in technological advances in developing multiple online and interactive television courses that serve students in rural and remote areas who could not otherwise attain a college degree. The educational achievements of this school, and the opportunities it affords for the expansion of knowledge, culture, and training, are manifest in the recognition and support currently and historically given it by area residents and businesses, by state agencies, and by Oklahoma peer institutions.

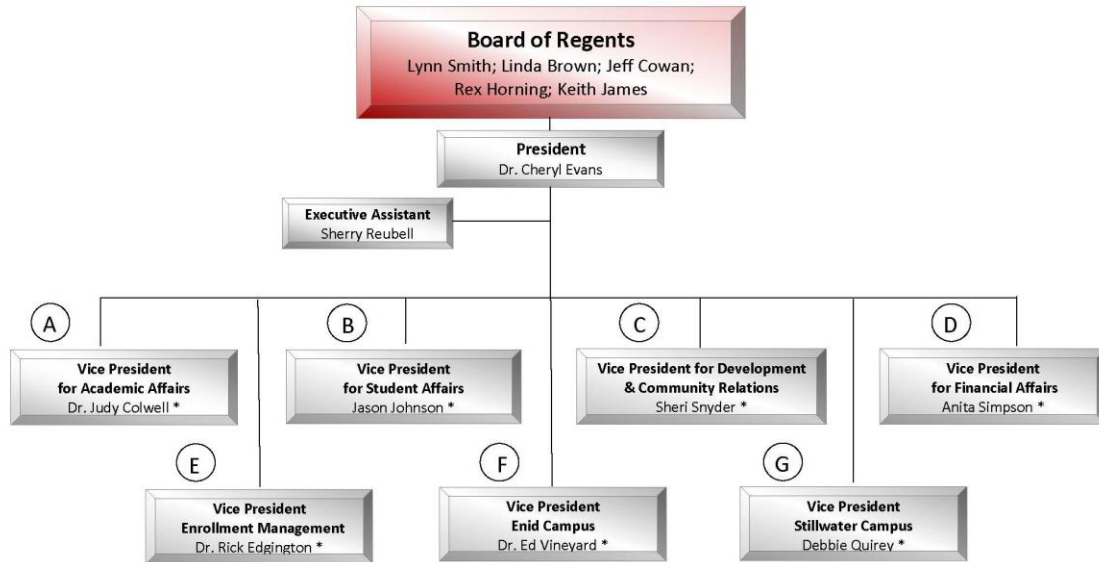

## High-Impact Strategies

- NOC's Gear Up Coordinator has been working with 4 high schools—Caney Valley, Guymon, Newkirk, and Woodward—to help prepare more students for college success.
- NOC worked with Enid Public Schools in a partnership to expand college-level course offerings taken by juniors and seniors at their new \$6.5 million, 16-classroom, four-laboratory building, designed to house AP courses and concurrent enrollment.
- Remedial Boot Camps were created for the Fall 2013 semester to allow students a period of intensive review during the first week of remedial courses and an opportunity to fast track into a college credit-bearing course.
- A new full-time remedial science instructor was hired for Fall 2013 to coordinate Basic Science curriculum across 3 NOC campuses.
- NOC's VP for Enrollment Management, Dr. Rick Edgington, has worked with peers at the University of Central Oklahoma, Northwestern Oklahoma State University, and Oklahoma State University to identify strategies for reverse transfer. Through a pilot program with UCO, this discussion led to attorneys drafting new language at the federal level rewriting FERPA guidelines. This helped to expedite the process and raise the number of graduates in Oklahoma and to serve as a national model for reverse transfer. To date, 813 students between UCO and OSU have been targeted in reverse transfer initiative.
- All division chairs have been reviewing options for certificates within their discipline, with the aim of identifying areas in which labor market data could support employability at the certificate rather than degree level.
- In addition to regular participation in the state transfer matrix meetings, maintaining strong articulation agreements with partner transfer institutions continues to benefit students through curriculum alignment for ease of transfer.

Age Distribution for 2012

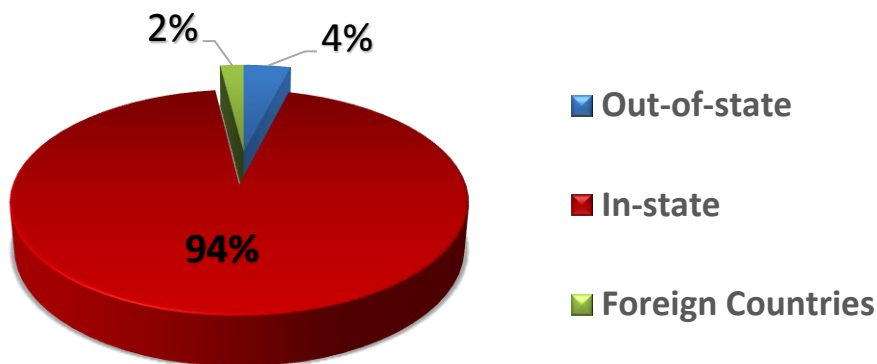

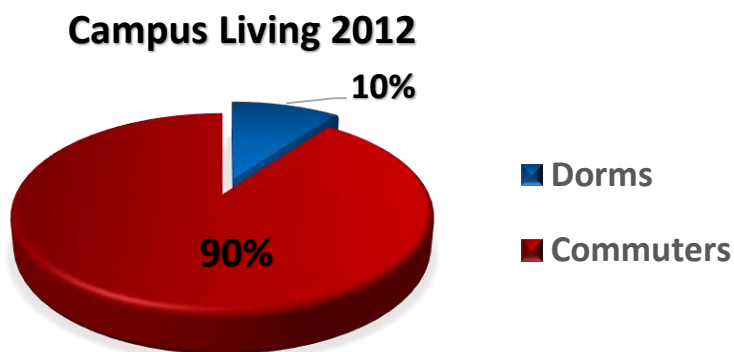
Residence of First-time students 2012





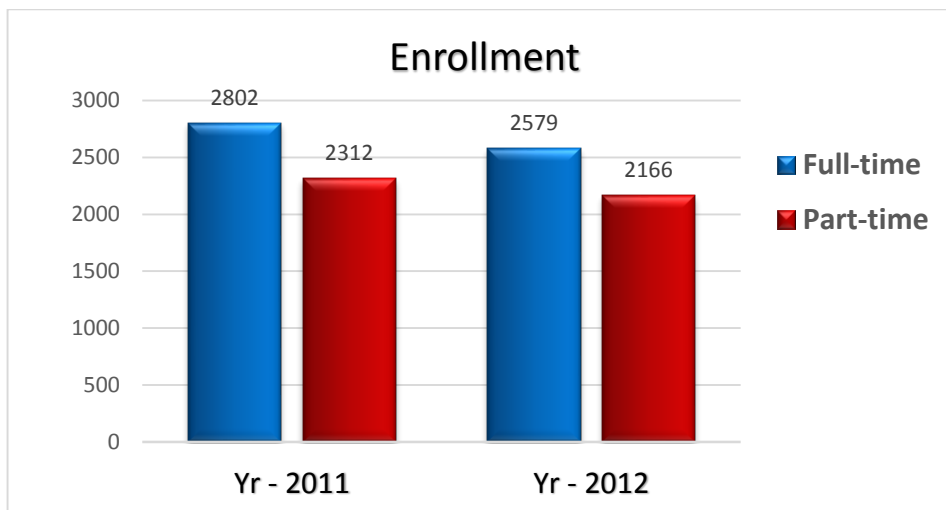

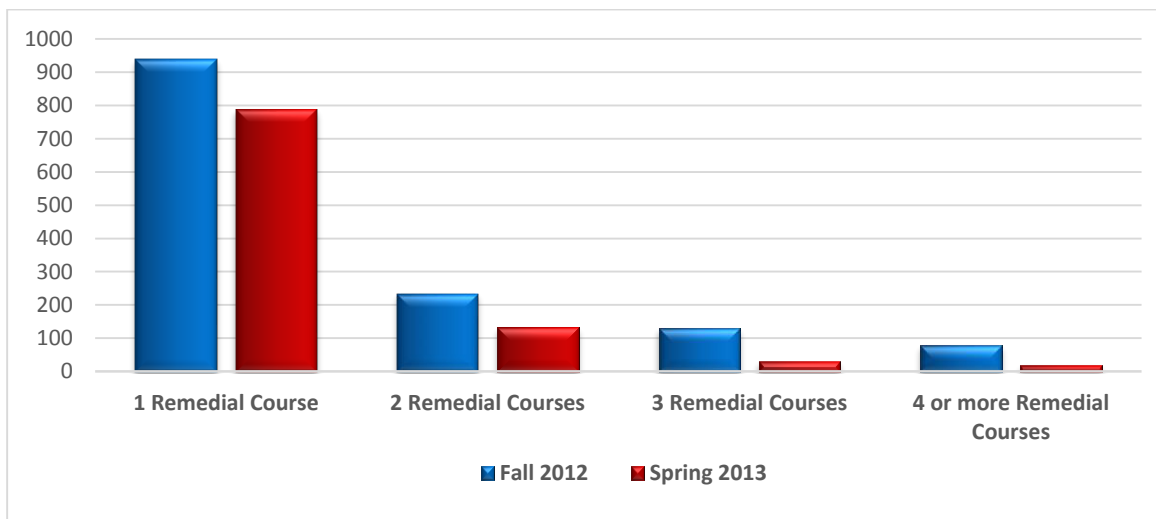

### Student Enrollment in Developmental Courses

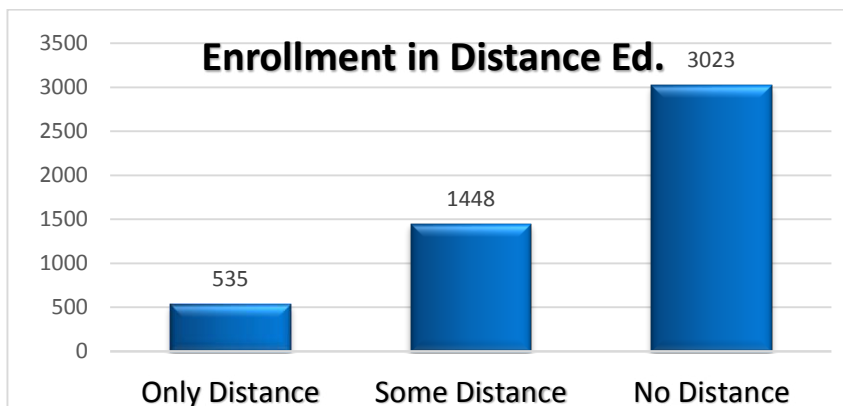

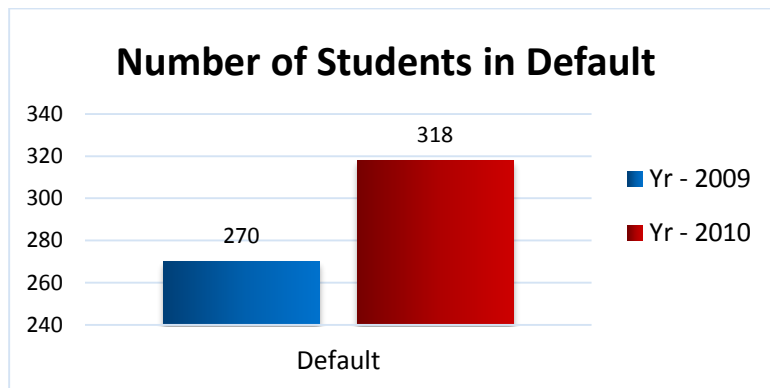

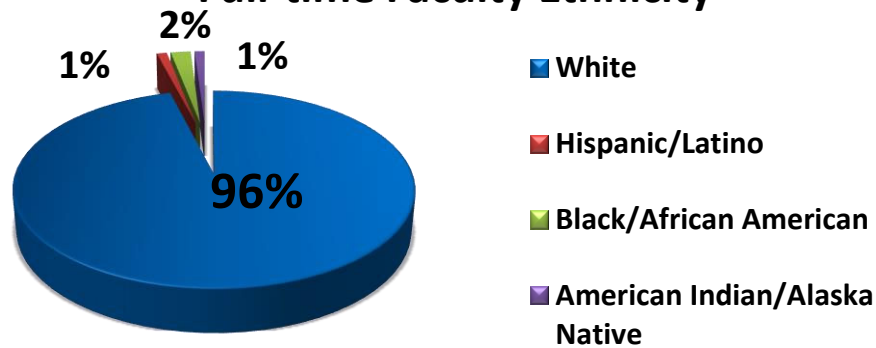
