Region 2 Playoffs start Wednesday

It is bedlam revisited, this time in the basket-ball playoffs.

The NOC Enid Lady Jets face rival Tonkawa Wednesday in the NJCAA Region 2 Tournament in Shawnee at Oklahoma Baptist University.

Tip-off is set for 1 p.m.

The Lady Jets (13-8) are the fourth seed with an 11-5 record while the Lady Mavs (12-14) are the fifth seed with a 7-9 league mark.

NOC Enid swept the Lady Mavs 86-62 and 80-74 in the regular season.

The winner faces the Eastern-NEO winner Friday at 1 p.m.

The NOC Enid Jets face top seeded NOC Tonkawa in the NJCAA Region 2 Tournament in Shawnee at OBU.

Tip-off is Thursday at 6 p.m.

The Jets (11-19) were 4-12 in the OCAC, while the Mavericks (21-7) were 12-4 in league play.

The Jets lost to NOC Tonkawa 75-63 and 82-69 in the regular season.

The winner faces the NEO-Seminole winner Friday at 8 p.m.

YOU COULD QUALIFY IF YOU:

- Have lost your job or income due to COVID-19 on or after March 13, 2020 -AND-
- 2 Live in Oklahoma and are behind on your rent and/or utility bills

If anyone has lost any form of income due to the pandemic, we encourage you to apply for help with rent or bills through RSVP. CCP has the funds to help pay almost all bills owed if you have been affected by COVID in any way.

It is super easy, so long as we have the below information ready to go!

- Photo ID
- Utiliy Bills (Water, Gas, Electric Bill)
- Landlord contact info: phone, address and email address
- Receipt of last payment for rent

Additional documents to bring if you have them but are not required to apply:

- Social security number
- Tax return from 2020 or statement of income for SSI or Disability
- Updated Lease agreement
- COVID-impact letter (i.e. letter from doctor or hospital, old employer etc.)
