

### **Camp Waiver and Release of Liability Form**

I hereby give my permission for my child(ren) to participate in the camp at Northern Oklahoma College (NOC).

Participation in any program which involves physical activity exposes the camper to certain risks and dangers. Accidents and injuries are always a possibility, and it is impossible to foresee and protect the camper from all conceivable dangers.

I hereby affirm that my child(ren) has/have no conditions that would make it unsafe for him/her/them to participate in the camps programs.

I understand that NOC may exclude my child(ren) from Camp in the event that I or my child(ren) fail to abide NOC's protocols, disrupt, impede or interfere with the operations of the Camp, or threaten the health, safety or welfare of other participants or Camp staff, and that no refund of any fees will be made in such circumstances.

I understand if my child(ren) causes intentional damage or destruction of NOC property that I can be charged for those damages.

**Medical Consent:** I understand that the Camp Director will make every effort to contact me in the case of an emergency. I give my permission for the Camp Director to administer any medications needed and to provide and arrange for and consent to any necessary medical treatment for my child(ren) while at NOC, including onsite and offsite emergency care. #### **Photo/Video/Audio Release**

I hereby grant NOC the absolute and irrevocable right and permission, in respect of the photographs, audio and/or video taken of my child(ren) alone or with others, to use, re-use, publish, and re-publish the same in whole or in part, individually or in conjunction with other photographs or video, and in conjunction with any printed matter, or electronic matter, in any and all media now or hereafter known, and for any purpose whatsoever; and to use my child(ren) name in conjunction therewith if NOC so chooses. \_\_\_\_ I accept \_\_\_\_I decline.

By signing this Waiver and Release of Liability, with full appreciation of the risk involved, on my own behalf and on behalf of my child(ren), I hereby voluntarily release and forever discharge the NOC, its trustees, officers, employees, agents, insurers and contractors from any and all legal or financial responsibility for any personal injury, disability, illness, damage, medical expense or death, arising from or related to my child(ren)'s participation in Camp. I agree, for myself and my child(ren), not to make any type of legal or equitable claim on NOC, or any of its trustees, officers, employees, agents, insurers or contractors with respect to any injury I or my child(ren) may suffer, whether or not it arises through the negligence, omission, default or other action of anyone affiliated with NOC, including other campers. I further agree that if any such claim is made, I will indemnify and defend NOC with respect to any such claim, injury or damage.
